Our specialty is bringing together emerging leaders from across industries, to cross-develop and encourage a broad knowledge and develop a foundational, and current, leadership skillset.

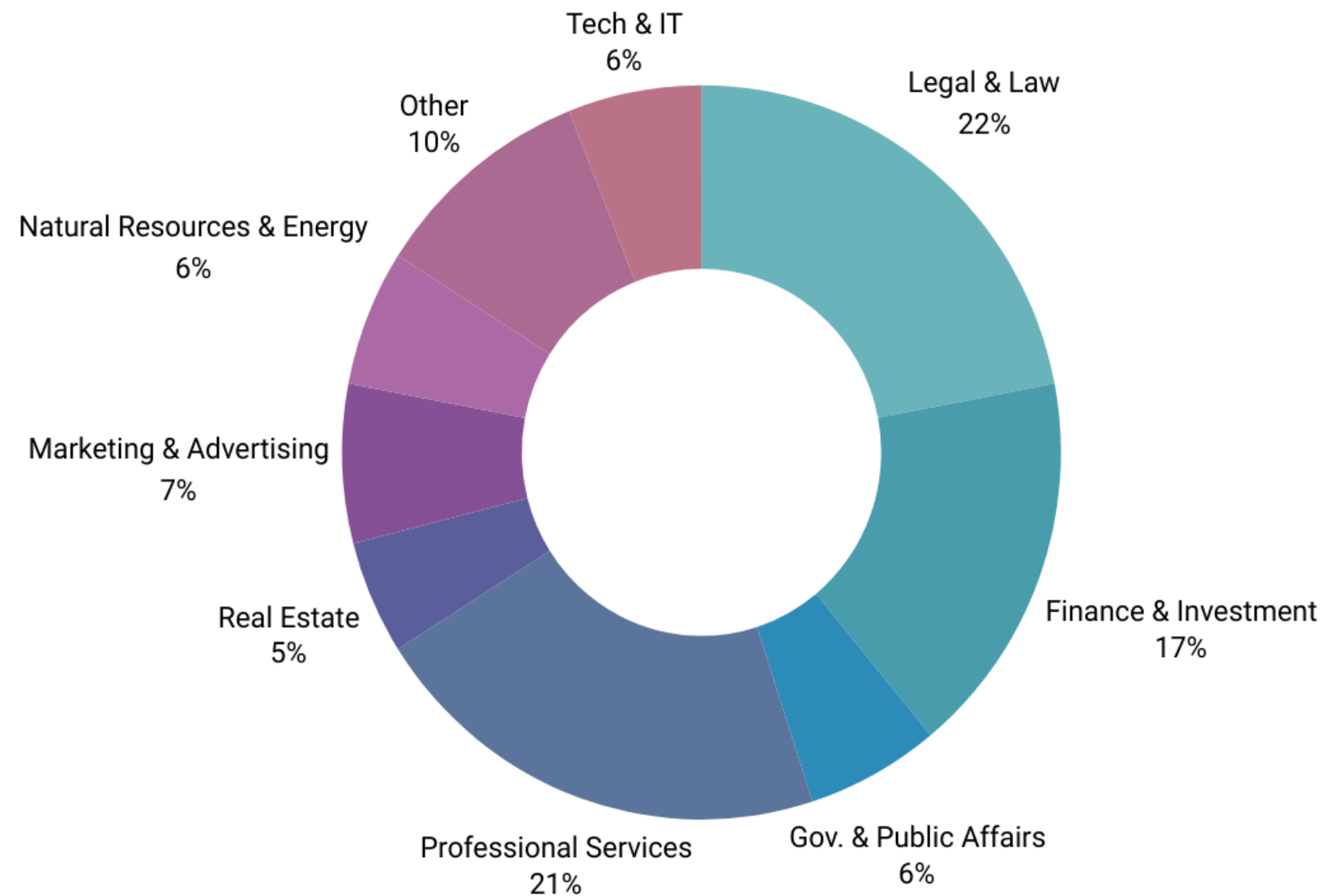


Our Members

Member Industries



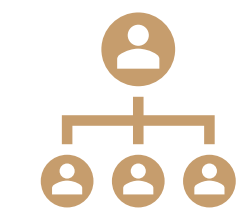
Member Facts

Frequently Asked Questions

What is the Corporate Membership term?

- All BJCC Corporate Membership tiers have a 12-month term.
- Membership is active from the time of sign up for 12 months i.e. it is not fixed to the financial or calendar year.
- The BJCC will stay in touch ahead of your renewal time.

How does my organisation sign up for Corporate Membership?

What is involved in managing a Corporate Membership?

- Corporate Membership is managed through our CRM system, Glue Up.
- Upon sign up, you will assign a Primary Contact from your organisation to be the main administrator or your Membership.
- The Primary Contact will invite people to activate their individual profiles within the Membership.
- The BJCC will support you along the way.

How do I redeem the complimentary ticket allocation for events?

- A ticket type dedicated to your Corporate Membership will be loaded to each event.
- Your Members can register individually, or the Primary Contact can coordinate registrations to stay across how many tickets remain.
- The BJCC can update you at any time.
